- (c) The Vendor reserves the right to, at any time before acceptance of a tender, withdraw any specified residential property from sale or to sell or dispose of any specified residential property to any person by any method (including, without limitation, private treaty, tender and auction).
- (d) The Vendor reserves the right to adjust the closing date and time of the tender by amending the relevant Information on Sales Arrangements relating to the specified residential property(ies). Any adjustment of the closing date and time of the tender will be posted at the Sales Office. The Vendor is not obliged to separately notify the Tenderers of such adjustment. In the event that Typhoon Signal No.8 (or above) or Black Rainstorm Warning Signal is announced or is still in effect after 12:00 p.m. on the closing date of the tender, the closing date and time of the tender will be extended to 5:00 p.m. on the next day and in respect of which no Typhoon Signal No.8 (or above) or Black Rainstorm Warning Signal is announced.
